A modern farmhouse style was selected to perpetuate context - it pays homage to the house that once stood on the site, by maintaining portions and orientation of the prior footprint.

With emphasis on the lake outside and utter comfort and luxury within, the structure has walls of windows, high ceilings, and an exceptional eat-in chef's kitchen with high-end appliances. The house features a main level master bedroom suite, offices, sunroom, solarium/potting room, laundry, pantry, powder room and wet bar, all on the first floor. The upper level has three bedrooms and a family room with doors overlooking the lake. Two full baths and a second laundry room complete the upstairs. The lower level of the house offers a spacious gym and full bath. The vanishing-edge salt water pool, glass-walled pool house, hot tub, outdoor shower, outdoor fireplace, and gracious stone patios maintain utter luxury al fresco; the lush and level lawn leads to a private sandy beach, dock, and boat shed.

High efficiency mechanicals include zoned, geothermal heating and cooling, radiant floors, constant humidifier/dehumidifier, generator, central vacuum, security system, and heated three-bay garage.
